# ALL MCA PARENTS AND PERSONNEL

The purpose of this communication is to provide you with information and answer questions about possible school closings, and other interruptions to school or school activities. We believe when parents, students, staff, and others are informed of procedures and rationale in advance, they can respond responsibly when severe weather or other emergencies occur.

### **GENERAL CONSIDERATIONS**

Emergency decisions to **close in-person**, **the on-campus school** are made to protect students from the potential harm of severe weather and other hazards.

- MCA will conduct the in-person, oncampus school in the normal manner if there is a reasonable expectation that 85% or more of the students will be in attendance. Please realize the school draws students from a wide geographic area.
- When possible, decisions to close inperson, on-campus school will be made by 5:30 a.m. or no later than 6 a.m.
- MCA will work closely with the Osseo school district, Mn/DOT, and other appropriate offices in making decisions regarding closings, etc.

#### **COMMUNICATIONS**

Communication during any emergency is critical to safety. In-person, on-campus school closing announcements and other emergency-related

information will be broadcast primarily via radio, TV, websites, MCA App, email, Facebook, Instagram, and Twitter. When possible, early morning decisions are reported to stations by 5:30 a.m. or no later than 6 a.m. The radio, TV stations, and websites that will have our closing information are as follows:

#### Phone

- You will receive an automated FACTS message alert to the cell phone number on file with the school.
- Please do not phone the school with questions during an emergency. Such phone calls only delay emergency operations, tie up phone lines needed for

school-wide action, and consume the time of staff when their time is needed to respond to the emergency.

### Text

 Parents listed in the school information system will receive a text with information on any school closing, delays, or emergencies.

# INCLEMENT WEATHER: E-LEARNING DAYS

The first inclement weather day will be a snow day. All other closures will be E-Learning Days unless otherwise noted. Online learning days require all students to participate in prescribed school lessons assigned by their teachers. The following is a detailed description of how students will access their assignments and expectations for participation.

# **Grades Pre-K–4 Teacher Expectations**

- Classroom teachers will email parents their grade level E-learning Day activity matrix by 8:30 a.m.
- Teachers will be available via email or Schoology messaging from 8:30 a.m.– 3:30 p.m.

- Students complete a portion of the activities as directed and record them with a check mark on the activity itself.
- The activity is to be sent back to school with a parent or guardian signature the next day school is in session
- Students will be graded on the returned activity with an overall completion/ participation grade which the homeroom teacher determines.
- If this poses an extreme hardship on the parent or guardian's work schedule, please make the classroom teacher aware and a 24-hour extension can be given to families to finish the assigned work.

# **Grades 5–12 Teacher Expectations**

- On an E-learning day teachers will open up links in Schoology for that day's classes
- Teachers will follow typical Virtual Learning practices of logging into each class at the beginning of class.
- Teachers will teach via Microsoft Teams.
- Teachers will design lessons on the premise that the students do not have anything at home except their device; all materials for successful completion of the assignment will be provided through Schoology.
- Teachers will give credit in the grade book for the work assigned on a severe weather closure day.

# Grades 5–12 Student Expectations

- On an E-learning day teachers will open up links in Schoology for that day's classes
- Students are expected to log into each class via Microsoft Teams at the start of each class for instruction and assignments.
- AA/PSEO classes will use Moodle/Zoom.
- Students are expected to submit completed work to each teacher according to posted due dates or by the next class period. In some cases, teachers may require online submission to take place on the day of the school closure.

# Grades Pre-K–4 Student/Parent Expectations

# TWO-HOUR LATE START (VERY RARE)

- Designated first-tier staff will report to school at 7:00 a.m. and will be responsible to supervise students until the remaining staff arrives by 8:15 a.m.
- School will officially start at 10:00 a.m.; however, students arriving before the start time may report as early as 7:00 a.m. to the cafeteria.
- At 8:15 a.m., lower school students will be released to their grade level classroom(s) and provided with ungraded activities as needed until the official start time.
- At 8:15 a.m., upper school students will be released to their advisory classroom and be in an unstructured study hall until the official start time.
- At the official start time, the upper school's first two class periods will run on a shortened schedule and the afternoon classes will run as normal.
- There will be no breakfast option available for late start days.

# EARLY DISMISSAL

MCA will not do an early dismissal due to weather once school is in session. The risk of sending students home to unsupervised or locked homes and the hardship presented to working parents is our primary reason. Parents may elect to pick up their children or call to have them released early from school.

# **OTHER PROCEDURES**

#### Procedures for extreme cold

Extreme wind chill can be very dangerous. If the wind chill is excessively bitter at 5:30 a.m. and predicted to remain the same or become worse, school will be canceled. Usually, additional adverse weather conditions are necessary to cause school interruptions other than wind chill.

#### Procedures during snow or ice storms

If a storm occurs or continues during the night, we will consult with snow removal officials when possible, and follow weather reports. When possible, a decision will be made by 5:30 a.m. or no later than 6 a.m. whether school can be started with reasonable safety. If a storm occurs or worsens during a school day, the same procedures will be followed with a decision by noon for extra-curricular activities. X-Tended Day will not be canceled if school is in session.

# Extra-curricular Activities (when school is closed)

When school is canceled, all school-related activities are also canceled i.e., extracurricular activities, clubs, X-tended Day, and athletic events with the exception of Section or State competition which is determined by the Minnesota State High School League (MSHSL) Exceptions may be made to accommodate unique situations, i.e., theater productions, etc. **Procedures for other emergencies** It is not possible to outline all hazards and conditions that can cause dismissal or disruption of the school day. Most hazards rarely occur. Parents should be assured MCA will cooperate fully with other agencies and officials whenever dangers due to fire, tornadoes, power failure, gas leaks, or if other emergencies occur. We will do everything within our power to protect the health and safety of the students.

#### **Obligation of parents**

Parents should be certain their children are appropriately clothed, instructed, and otherwise prepared for emergencies, particularly weather emergencies. Parents should monitor communication outlets for reports during times of severe weather. If parents disagree with a decision to hold school on a day when they feel the weather is hazardous, they are encouraged to keep their children home.

# OTHER THINGS YOU SHOULD KNOW...

- The school has a Crisis Management Plan in place to deal with emergency situations.
- State law requires schools to have five fire drills per school year. Every effort is made to hold fire drills when the weather is good. Five lockdown drills and one tornado drill are required by law and are scheduled each school year.
